## **The Rhenus & Hellmann Joint Venture in Großschirma, Leipzig, Kesselsdorf and Nossen will become Hellmann Worldwide Logistics**

As of December 1, 2021 Hellmann Worldwide Logistics group will fully legally integrate the former joint venture Rhenus & Hellmann GmbH & Co. KG including locations at Großschirma, Leipzig, Kesselsdorf and Nossen.

Of course, we will continue to offer you the usual service at all locations and will even expand the product range. The known shipment portals you are familiar with will be available until January 31, 2022. The "Hellmann Portal" will substitute these portals on February 1, 2022. You will receive further information in this regard at the right time.

**On December 1, 2021**, the assets of Rhenus & Hellmann GmbH & Co. KG will be transferred by way of an accretion under company law ("*Anwachsung*") to **Hellmann Worldwide Logistics Germany GmbH & Co. KG**. All rights and obligations as well as in particular contractual relationships of Rhenus & Hellmann GmbH & Co. KG will automatically be transferred to **Hellmann Worldwide Logistics Germany GmbH & Co. KG** by way of universal succession.

It is therefore necessary that, with effect from December 1, 2021, you list Hellmann Worldwide Logistics Germany GmbH & Co. KG into your master data instead of Rhenus & Hellmann GmbH & Co. KG and adjust the bank details accordingly.
