# Revision of the Infection Protection Act as of November 24,2021

Dear valued Customer,

Due to the current development of the pandemic situation in Germany, the new regulation of the Infection Protection Act (IfSG) has come into force with effect from November 24, 2021. We are pleased to confirm that we fulfill all resulting obligations as an employer. In addition, all transport service providers we employ have been made aware of their legal obligations as employers concerning their drivers.

Of course, you as our customer but also your customer as consignee can stipulate certain access requirements or restrictions for the respective company premises as the owner of the house rights, even if these should exceed the legal or official requirements in individual cases.

However, we would like to point out that the carrying of a current negative test or a certificate from Hellmann regarding complete 3G tests, which is sometimes expected of the driving personnel, is not a legal requirement. In such cases, there is an obstacle to transport or delivery.

Accordingly, we will immediately contact our client to obtain instructions. If transport orders cannot be carried out (delivery or pickup), we must return the consignments at the customer's expense. Please understand that storage of these shipments will not be possible.

We therefore strongly recommend that you clarify with the respective recipients before sending out your shipments whether they are able and willing to accept them in the usual way without special requirements.

We thank you for your cooperation, and we are sure that we will master the renewed challenges with regards to the Covid-19 pandemic together with you in the usual cooperative relationship.
